The undersigned further guarantees full payment of any debts of East Idaho Auto Auction Inc., including any checks or drafts issued by Dealer or any of Dealer's representatives, together with any loss or expense incurred by East Idaho Auto Auction Inc. in collection or attempting to collect such debt, including attorney's fees.

The undersigned further guarantees the Odometer Mileage Statements given by or on behalf of the Dealer in all sales of motor vehicles by it through East Idaho Auto Auction Inc., and agrees to reimburse, indemnify and hold harmless East Idaho Auto Auction Inc. from all expenses and losses caused it by any Odometer Mileage Statement which proves to be false or inaccurate, including payments made by East Idaho Auto Auction Inc. under any Odometer Statement Guarantee issued by it in connection with any such sale, as well as any costs or expenses incurred by East Idaho Auto Auction Inc., in collection or attempt to collect such losses, including attorney's fees.

The Undersigned acknowledges that East Idaho Auto Auction Inc. shall have the right to refuse to transact business with Dealer, to alter or release any and/or all collateral security, to extend or change time of payment and to settle or compromise with Dealer without notice to the undersigned and without discharging or affecting the liability of the undersigned. This Guarantee is intended to be a continuous guarantee and the undersigned hereby waives notice of the acceptance of this guarantee and protest, demand presentment and any notice of non-payment or dishonor. The undersigned shall be liable to principal debtor and not merely as surety, and the bankruptcy or any assignment in favor of Creditors of Dealer shall not affect the enforceability of this agreement.

This instrument shall bind the respectful heirs, executors, administrators, and assignees of the undersigned, and shall ensure to the benefit of East Idaho Auto Auction Inc. assignees and its successors.

In the case of more than one signatory to this agreement, each signatory shall be jointly and severally liable under this agreement.
